SUBJECT:	NOTICE TO SDPs TO SUBMIT EXTE ASSESSMENT (EISA) ENTRY PACKS FOR APRIL 2025		

1. PURPOSE

This memorandum seeks to notify SDPs to enter registered learners/candidates for the upcoming EISA exams planned for 10th April 2025.

2. BACKGROUND

It is the QCTO requirement (assessment domain) that all learners eligible to write EISA exams are entered for examination for every planned EISA session. SDPs are responsible for submitting EISA entry packs to INSETA.

No candidates will be entered into the EISA exam without submitting EISA exam entry packs to INSETA.

3. LEGISLATION/POLICY/FRAMEWORK

The Quality Council for Trades & Occupations (QCTO) is a Quality Council established in 2010 in terms of the Skills Development Act (Act 97 of 1998) as amended in 2008. The QCTO among other things is responsible for the following:

- a. Management of the Occupational Qualifications Sub-Framework (QQSF).
- b. Accreditation of Skills Development Providers (SDPs)
- c. Research & Knowledge Development
- d. Development and Maintenance of Occupational Qualifications
- e. Accreditation of Assessment Centres
- f. Stakeholder Management and Advocacy
- g. Assessments & Certification of Candidates

4. SUBMISSION OF EISA PACKS (DOCUMENTS)

4.1. EISA packs must be submitted via email to esethur@inseta.org.za copy stanleym@inseta.org.za

4.2. Deadline for submission of EISA packs must be submitted no later than 3rd Feb 2025 (no entries will be accepted after the date.

4.3. Only learners deemed legible to write the EISA will be allowed entry inti the EISA exam: QCTO will confirm eligibility to to INSETA.

- Candidate ID Copy.
- Completed SDP Statement of Results (QCTO template).
- Learner declaration/readiness form to write EISA exam (INSETA template).
- Proof of LEISA submission to QCTO (consolidated list).

5. SUBMISSION NOTES

- No packs shall be accepted past the deadline date.
- Incorrect packs will be sent back to the SDPs for correction & re-submission.
- INSETA will confirm eligible candidates/learners through individual exam permits.
- The candidate/learner readiness declaration form must be completed in full and correctly.
